

If you are interested in donating your time and energy please consider if Trauma Response is right for you. We have available a private survey to help you with your own decision making process. Trauma response is not for everyone and we all have times in our lives or with families when the timing does not work. But events like the recent fire storms causes us to reconsider priorities. We can help by providing this aid to you for your own use.

If you think you might be ready (with training) there is a definite need. The following statistics highlight the need:

Following the Oklahoma City Bombing -

8898 individuals received psychological first aid or support group services

53 people received counseling for every one death (mathematical ratio)

186,000 people received additional services\* -

Contacts by outreach workers

"Debriefing" sessions

**Educational services** 

Trial support services

\* Mathematically, this number equals about 1000 mental health contacts per death. If you are not ready to commit but you are interested please send an email to:

## IE-CAMFT PRE-LICENSED EXCHANGE

#### ASK BEN

My name is Ben Zinke and I'm a pre-licensed board member at large for IE-CAMFT. The board is interested in starting up a pre-licensed section of the monthly newsletter. The purpose of the Pre-Licensed page will be to give interns and trainees a forum to discuss issues that they often face.

Dear Ben,

I am an MFT Trainee and work at an agency. I had a reasonable suspicion that one of my clients, a 10 year-old boy, had been abused. When I told my supervisor, she told me not to report it to CPS because at the agency they try to handle those matters directly with the parents. I remember from my Law & Ethics class, I'm supposed to report all suspicions of child abuse. Should I listen to my supervisor, since she told me to not report, or should I report, as I learned in my Law & Ethics class?

#### Dear Cecile,

You were right in asking your supervisor before you do anything, especially because you are operating under her license. However, you are also right about the fact that you are supposed to make a CPS report if you are reasonably suspicious. I understand how confusing this must be for you. Personally, I would contact CPS and ask for their advice as to whether this is a reportable incident. If they think it is reportable I would finish the phone report and send a written report immediately.

I want you to be aware that you could be fired for doing this, but it's the right (not to mention legal) thing to do. Your supervisor could lose his license and you could be criminally prosecuted and have complications with ever getting your license if it was discovered that you were not reporting when you should have. I assume your supervisor was worried that a report to CPS would damage your relationship with the client and that the clinic would lose business if they reported every time. While this is a legitimate concern, an agency that is worried about losing too much business because of CPS involvement might not have the right moral attitude. As a therapist it is your duty to protect children. In every case you must do what is ethical and legally required, and hopefully this is "in the best interests of the child". CPS is there for a reason and they have resources that your agency does not. Their mission is not to just pull kids out of homes. To the extent they can, they provide services to keep families united and to reunite the family if a child was removed.

If you are still having doubts about what you should do, keep in mind that for every day that goes by that child might be enduring abuse and thinks they told YOU. It might be a good idea to see if you can get some support on this issue from your school and from you classmates. No matter what happens here it would be good for you to have support. If a member of CAMFT, you may call their attorney for consultation.
