Update on Paying for Supervision

On January 23, 2010, the Board of Behavioral Sciences ("BBS") met in Sacramento. Discussed during the meeting was the issue of "paying for supervision." Unfortunately, the BBS scheduled this very important item late on their agenda; therefore discussion was cut short. Since that meeting, the Executive Officer of the BBS has committed to schedule another meeting where this matter will be a key topic of discussion.

During the discussion, the BBS counsel reiterated his interpretation of the Labor Code indicating that: "employed" interns/trainees/associates may not pay their employers for supervision. His opinion is that volunteers are not employees and may pay for supervision. His opinion was also that it continues to be lawful to pay for "offsite supervision" that is not provided by the employer. Further, the BBS indicated that there would be no intent on their part to enforce the interpretation that paying one's employer for supervision is unlawful unless they received a specific complaint. In other words, an intern paying an employer for supervision would not result in the loss of hours of experience for the intern. The BBS further concluded, based upon counsel's recommendation, that the issue of "paying for supervision" did not fall under their jurisdiction, and the matter should be addressed with the Department of Industrial Relations, Division of Labor Standards Enforcement (DIR).

During this limited discussion CAMFT disagreed with the BBS's interpretation of law and their contention that this issue falls outside of the purview of the BBS. We argue that the supervisee/supervisor relationship as we know it in the mental health disciplines is different than the typical employee/employer relationship where supervision is oversight to serve the interests of the employer. Supervision as we know it for interns/trainees/associates is provided for the benefit of the person being supervised and is intended as a training experience as required by the licensing law. It is a condition of the supervisee getting the requisite experience to qualify for a license that he or she will gain. The employer has no direct gain from the intensity of this type of supervision.

James Maynard, Counsel to the BBS, cites various Labor Code Sections to make his case against employers being able to collect for supervision. Our reading of one of the sections cited appears to say that it is unlawful when an employer makes a deduction from an employee's wages for certain things (which would be the case with supervision). This same section of law, however, makes an exception when there is a "wage agreement" that is expressly authorized in writing by the employee. We argue that if the employee agrees in advance, in writing, to authorize a deduction from his or her wages, a deduction for supervision could be considered lawful.

It is interesting to note that if the issue of paying for supervision is beyond the jurisdiction of the BBS, it was BBS-sponsored legislation that removed, just a few years ago, the explicit prohibition against paying for supervision in a private practice.

We will continue to pursue the matter with the BBS. We likewise plan to pursue the matter with the DIR and may involve others in this process. Depending upon the results of these efforts, we may pursue legislation to address the problem. Unfortunately, any legislative strategy this year is foreclosed due to timing, unless the BBS agrees to put it into a non-controversial committee bill.

CAMFT understands the immense frustration and confusion felt by interns, trainees, associates, supervisors, employers, and agencies, however, please know that CAMFT is attempting to interpret and advise on this situation as quickly and efficiently as possible. As CAMFT achieves this goal, we are cognizant of the need to protect interns/trainees/associates from some employers who may be predatory while assuring that there are an adequate number of settings to gain qualifying supervised experience.

Members may also submit written proposals to the CAMFT Board for consideration. Such proposals should provide a complete description of the action being sought by the Board. CAMFT staff can provide a proposal form for anyone seeking to make a written request of the Board to take action.

GoLightly—New Social Networking Media for Members

The Board discussed the new social networking media (GoLightly) that will be rolled out to members this spring. This media will replace the listserves and provide much greater versatility for member dialogue. Members will be able to include pictures with their exchanges to make interactions more human. Members will also be able to take their conversations in various directions based on degree of interest and personal focus. It may also offer opportunities for members to learn more about candidates for the Board prior to voting.

Board Member Commitments

CAMFT Board Members make commitments to be present with one or more CAMFT Chapters. Board Members may attend one or more Chapter Meetings, make presentations at Chapter Meetings, or assist with guidance to help a struggling chapter re-create itself. Board Members also make commitments to contact state and federal legislators. And, Board Members commit to identifying and encouraging strong candidates to run for the CAMFT Board of Directors. Board Members also commit to contributing to CAMFT's state and federal political action funds.

Filling of Board Vacancy

The vacancy on the CAMFT Board resulting from the resignation of Patrick Healy was filled by an existing Board Member as is required by the Bylaws. Patricia Teague fills this vacancy for the remainder of the Board year—until May 31, 2010. The remaining vacancy on the Board was filled by J.M. Evosevich, a prior CAMFT Board Member and President. This term will likewise end May 31, 2010.

Filling of Vacancy on Ethics Committee

The vacancy on the CAMFT Ethics Committee created by the resignation of Jim Walt will be filled by Mary Ellen Edwards McTamaney. Jim resigned due to competing demands for his time. Mary Ellen is a prior Board Member and President of CAMFT.

Meeting with Representatives of the California Coalition for Counselor Licensure

The CAMFT Board met and dialogued with representatives of the California Coalition for Counselor Licensure, the proponents of the legislation to license LPCCs in California, to discuss common purposes and possible activities for cooperation and collaboration.

Funding Streams for Grants for Diversity and Inclusiveness

The Board directed CAMFT staff to look into how California MFTs can be eligible for minority fellowship grants through SAMHSA.

Sierra Foothills Chapter

The Board approved the charter of the Sierra Foothills Chapter of CAMFT.

Collaboration with the International Association of Marriage and Family Counselors

Board Members previously met with and discussed a proposal to develop a collaborative relationship with the International Association of Marriage and Family Counselors, a division of the American Counseling Association. The CAMFT Board agreed to develop a mutually supportive relationship that would, among other things, make IAMFC's peer-reviewed Family Journal available to CAMFT members and permit CAMFT members to submit articles for consideration to IAMFC's scholarly journal. The relationship would provide international exposure for CAMFT members, access to IAMFC's acclaimed video product line and training opportunities, as well as permit CAMFT members to avail themselves of their Family Therapy Certification. It may also lead to our discussions about ways to mutually support students in CACREP accredited programs in California.

Declaration of the Association of Family and Conciliation Courts, California Chapter

The CAMFT Board agreed that CAMFT would be a signer on a Resolution declaring a public health crisis in the State of California with regard to child custody proceedings and the state's failure to devote adequate resources to the needs of children in the family court system.

Social Activism Survey Results

Insights Worldwide Research, the firm who conducted the social activism survey, presented the results to the CAMFT Board. The Executive Summary and comments from the presenter will be distributed to CAMFT members. The results of the survey, exclusive of verbatim responses, will be available on the CAMFT website for member review. This issue will be on the Board's next agenda to determine how the recommendations are to be implemented. These results will also be available to Board Members at each meeting and at the Strategic Planning Meeting that will occur in the Fall.

Amicus Brief in Support of Perry v. Schwarzenegger

The CAMFT Board directed staff to review and sign an Amicus Brief in support of Perry v. Schwarzenegger, if it is determined that the brief is consistent with the CAMFT Marriage and Family Inclusion Statement and appropriately written and supported.

End of Year Finances of CAMFT

CAMFT was able to end the year in the black in spite of some loss of membership, the recession, and a decline in investment earnings.

CAMFT Membership as of November 30, 2009—29,600

The most common reasons for member terminations are financial or therapists are not practicing. Ninety-two percent of those who terminate believe the Association's services are excellent or at least good. One hundred percent believe *The Therapist* is highly informative or at least of some value. Eighty-eight percent believe the Association is working for the profession as it should.

Articles in The Therapist

The Therapist is to seek articles from members on their success stories or their mistakes that have turned into valuable learning experiences.

CAMFT Certified Supervisors

There are currently 307 CAMFT Certified Supervisors.

CAMFT Board Candidates

Nine persons appeared before the CAMFT Nominating Committee for consideration. The Committee selected five candidates from this number. Four of the candidates were from Northern California and five were from Southern California, four were female and five were male, three candidates were incumbents. Three candidates were deemed not ready and were not offered positions, one candidate declined to take the position offered.

While the CAMFT Board would like to see contested elections and believes it is the preferred situation, they recognize that it is not consistently possible if a Nominating Committee believes some candidates need more exposure to CAMFT and Board service before serving on the CAMFT Board. The CAMFT Board, in these situations, must support the process, wisdom, and decisions of the Nominating Committee.

LPCC Track for Pre-Licensed MFTs

In 2009, the Licensed Professional Clinical Counselor licensure law was passed and signed here in California. For already licensed MFTs, grandparenting is available from January 1, 2011 through June 30, 2011. For interns who expect to be licensed before June 30, 2011, they too will have the option to apply for LPCC grandparenting. However, pre-licensed members who wish to obtain their LPCC license, and who are already in the pipeline (but will not be licensed by June 30, 2011) will need to adhere to specific education and experience requirements, as well as take the required licensing examinations.

For those who are outside of the grandparenting timeframe, the required education and experience is reviewed below. However, the specific regulations still need to be drafted by the Board of Behavioral Sciences. For example, can you count any and all supervised hours of experience towards both LPCC and MFT licensure? Will the BBS require national and/or state-developed examinations? Will the BBS allow more than one course to satisfy a particular required core course content area? These types of questions still need to be addressed through regulation, and we will share that information as the regulations evolve. As to the general education and experience required, please see thee the summary below!!!

Education Requirements

- Masters or doctoral degree that is counseling or psychotherapy in content obtained from an accredited or approved institution containing not less than 48 graduate semester or 72 graduate quarter units of instruction.
- Three semester units or four and one-half quarter units of graduate study in each of following nine (9) areas: counseling and psychotherapeutic theories and techniques; human growth and development; career development; group counseling; assessment, appraisal, and testing of individuals; multicultural counseling; principles of the diagnostic process; research and evaluation; and, law and ethics. NOTE: An applicant whose degree is deficient in no more than two of the required nine (9) areas of study listed above, may satisfy those deficiencies by successfully completing post-master's or postdoctoral degree coursework at an accredited or approved institution.
- A minimum of 12 semester units or 18 quarter units of advanced coursework to develop knowledge of specific treatment issues, special populations, application of counseling constructs, assessment and treatment planning, clinical interventions, therapeutic relationships, psychopathology, or other clinical topics.
- Six semester units or nine quarter units of supervised practicum or field study experience. $\mbox{\color{lm}}$
- A minimum of 15 contact hours of instruction in alcoholism and other chemical substance abuse dependency.
- A minimum of 10 contact hours of training or coursework in human sexuality.
- A two semester unit or three quarter unit survey course in psychopharmacology (at an accredited or approved institution).
- A minimum of 15 contact hours of instruction in spousal or partner abuse assessment, detection, and intervention strategies.
- A minimum of seven contact hours of training or coursework in child abuse assessment and reporting.
- A minimum of 18 contact hours of instruction in California law and ethics (school coursework may count towards this requirement.)
- A minimum of 10 contact hours of instruction in aging and long-term care.
- A minimum of 15 contact hours of instruction in crisis or trauma counseling.

Experience Requirements

- A minimum of 3,000 <u>post-degree</u> hours of supervised clinical mental health experience (under a qualified supervisor) related to the practice of professional clinical counseling, performed over a period of not less than two years (104 weeks.)
- Not more than 40 hours in any seven consecutive days.
- Not less than 1,750 hours of direct counseling with individuals or groups in a clinical mental health counseling setting.
- Not less than 150 hours of clinical experience in a hospital or community mental health setting.
- Not more than a <u>combined</u> total of 1,250 hours in non-clinical hours including: direct supervisor contact; client-centered advocacy; not more than 250 hours of testing and clinical report writing; not more than 250 hours of workshops or trainings; and, not more than 300 hours (100 x 3) of personal psychotherapy.
- No hours of clinical mental health experience may be gained more than six years prior to the date the application for examination eligibility was filed.
- NOTE: For more specificity as to the experience requirements (which are very similar to the MFT licensing law), please see Business and Professions Code, Section 4999.46, which you can access at leginfo.ca.gov.

Taking and passing the required licensing examinations.
