From the Frying Pan to the Jacuzzi Gourmet Recipes for a Gourmet Relationship

November's Speaker at IE-CAMFT: This workshop will provide participants an experience of relationship. We will begin by taking the twenty pieces of juicy fruit or knowings from the author's book and apply them to the various relationship we are experiencing at the moment in the meeting room.

Almost every couple tells me they need better communication skills. Lately, I've been responding with a little bit of a chuckle and the comment, "I won't argue that you don't know how to communicate, but I don't think that's your problem. Here's what I think the problem is. In the last ten years, couples, like yourselves, are searching for and have a deep desire to be in, for a lack of a better word, an EQUAL relationship, or a relationship that is characterized by equality and reciprocity and less by traditional roles, traditional expectations, or traditional norms. It's kind of exciting that, as couples, we want to be in an equal relationship, because it means that political and philosophical notions, such as democracy, are finding their way home into our day-to-day living, well beyond the voting booth and political structures of our country. Perhaps our desire and commitment to bring equality to our relationships is our own version of the war on terror! I am not an expert on gay relationships, but I would venture to say that this same movement, this same search for equality exists in gay relationships as well.

THE ABSENCE OF MODELS

And the rub or the real problem is this. As much as any of us desire to be in an equal relationship, we have no clue--no visible models--of what an equal relationship looks like. For example, there is nothing on television depicting a couple in an equal relationship.

What's It Feel Like?

And we don't know what an equal relationship FEELS like inside our body. We know the feelings that go along with falling and being in love. Unfortunately, like most feelings, they come and go pretty quickly! You might even know the feeling of being a part of a team that works together on a successful project, but what does it feel like to be in an equal relationship with our partner or spouse? Most of us are hard-pressed for an answer.....

Speakers Bureau

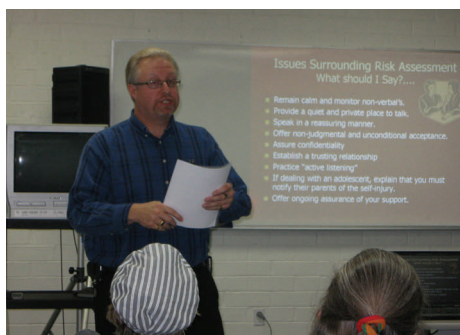

LEGISLATIVE UPDATE

State Government

The following California bills have been signed into law by Governor Schwarzenegger:

CAMFT Bill: Child Abuse Reporting

AB 247 (Emmerson)

This bill would amend the Penal Code (part of the Child Abuse and Neglect Reporting Act) to establish that licensed health care practitioners are not required to investigate child abuse and to correct the reference made to “medical practitioner,” which is a term no longer used. This bill has been signed by the Governor.

CAMFT Bill: Employment of Interns in CA Dept. of Corrections and Rehabilitation

AB 1113 (Lowenthal, Author and Anderson, Coauthor)

This bill would amend the law to allow persons aspiring to MFT licensure to be utilized within the Department of Corrections and Rehabilitation (CDCR), as is the case with persons pursuing the psychology and clinical social work licenses. This bill faced great opposition from a local union of the American Federation of County, State, and Municipal Employees (AFSCME—the union representing the interests of psychologists and clinical social workers employed within the CDCR.) But, in spite of the very vocal and heated opposition, the bill made it through the Legislature with only “yes” votes and has been signed by the Governor.

MFT Education

SB 33 (Correa)

This is a BBS sponsored bill intending to revise the educational requirements for aspiring marriage and family therapists. CAMFT is in support of this legislation.

The additional educational curricula, including, but not limited to:

- Co-occurring disorders and treatment of severe mental illness;
- Cultural competency and sensitivity;
- Understanding the effects of socioeconomic status;
- Professional writing and documentation of services;
- Finding and using resources, services, and supports for consumers;
- Case management;
- Understanding systems of care;
- Collaborative treatment; and,
- Advocating for persons with mental illness.

Additionally, some of the other features of the bill include:

- Increases the units of instruction from 48 semester/72 quarter units to 60 semester/90 quarter units;
- Eliminates the unit requirement on most courses, e.g., two semester/three quarter units in psychopharmacology—thereby increasing educational institution discretion;
- Increases the counseling hours required within the educational program from 150 to 225 hours, of which 75 may be client-centered advocacy;
- Increases to a maximum of 1,250 hours for supervision and hours of experience including professional enrichment with a maximum of 250 hours; personal psychotherapy with a maximum of 300 hours when triple counted; and client centered advocacy.
- Provides an incentive for treating couples and families where two hours of experience will accrue for each hour for the first 150 hours of such work;
- Modifies the supervision ratios for persons post degree to require at least one additional hour of direct supervisor contact for every week in which more than ten hours of client contact is gained in each setting (in other words, the person who works 30 hours a week in a job and who has an individual supervisor would be required to get two hours of supervision);
- Permits interns working in non-profit or governmental entities to obtain hours of direct supervision via teleconferencing;
- Requires interns, when applying for their licenses, to provide copies of their W-2 tax forms or letters verifying employment or volunteer work status; and,
- Places additional requirements on out-of-state applicants for licensure to remediate educational deficiencies to be reasonably consistent with the changes proposed for applicants who have been educated in California.

State Government (continued from previous page)

This bill will not affect persons already licensed or in the pipeline to acquiring licensure and will only affect those who begin graduate study on or after August 1, 2010. This bill will also recognize an MFT educational institution as “accredited” if it has been accredited by a regional accrediting agency recognized by the US Department of Education, which is significantly broader than the law was previously that recognized solely the Western Association of Schools and Colleges.

This bill has been signed into law.

Federal Government

Medicare

H.R. 3200: The *America’s Affordable Health Choices Act* was introduced in July and jointly developed by three House committees with jurisdiction over the issue. This Act includes a provision (Section 1308) that establishes Medicare coverage of MFTs and licensed professional counselors.

Senator Baucus Bill: The *America’s Healthy Future Act* was recently introduced by Senator Max Baucus, and on September 22nd, Senator Blanche Lincoln offered an amendment to the *Act*, which would establish Medicare coverage of MFTs and licensed professional counselors. The Senate Finance Committee is currently reviewing and editing the *Act*, and we are hopeful that the Lincoln amendment will be accepted.

We will continue to watch both the House of Representatives and Senate bills and update the membership on any changes or progress.

Department of Veterans Affairs

Although legislation to recognize MFTs as employable within the Department of Veterans Affairs facilities (“DVA”) was signed into law in 2006, the DVA has continuously procrastinated in implementing job specifications to make the 2006 law administratively operative. Over the last three years CAMFT has met with the DVA, as well as DVA Oversight Committee to pressure the DVA to produce the overdue job specifications. Until recently the DVA continued to drag its feet; but over the last few weeks we have seen substantial movement on the DVA’s part to work with CAMFT, and other advocacy groups, towards achieving the goals set out in 2006. The bad news is that the timeline to accomplish the job specifications likely be a year from now (there is an eight step process within the government to achieve these specifications). The good news is that the Oversight Committee, DVA Assistant Secretary, and Congressional members have pledged that this is a priority and will be accomplished as promised. We will continue to work with the DVA on this issue and will update the membership on any changes or progress.

NHSC Federal Loan Program

The National Association of Social Workers- California Chapter (NASW-CA), and the California Society for Clinical Social Work (“CSCSW”) have joined CAMFT in our work towards remedying the inequitable disparities in the National Health Services Corps (“NHSC”) loan forgiveness program against California Licensed Marriage and Family Therapists and Licensed Clinical Social Workers. The eligibility requirements of the NHSC loan repayment are incongruent with the licensure requirements of California licensees in that: a) the arbitrary COAMFTE accreditation requirement leaves out the majority of qualified California LMFTs, as well as many other state licensed LMFTs; and, b) the requirement that LCSWs pass the Association of Social Work Boards examination immediately rules out any California LCSW from ever applying for the loan forgiveness program. We are hopeful that our combined efforts will alert the NHSC to the inequitable disparities in this loan program so that they can be resolved.

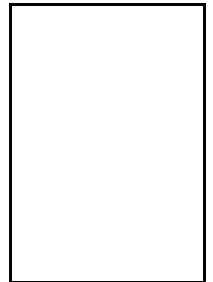
